





## **About Westmoreland County Community College**

Founded in 1970, Westmoreland County Community College lives its mission of improving the quality of life in its surrounding communities through education, training, and cultural enrichment. The college serves approximately 3,000 fulland part-time students across eight locations Westmoreland, Fayette, and Indiana counties and offers more than 100 associate degree, certificate diploma, and programs. comprehensive community college, Westmoreland prepares students for careers in a diverse array of fields or to transfer into baccalaureate degree programs at four-year institutions. The college is also committed to helping learners re-skill and up-skill in response to industry needs as well as providing personal enrichment opportunities for all members of the community.

The Youngwood Campus boasts updated facilities, including a Health and Culinary

Center that houses academic and administrative offices, classrooms, laboratories, a top-of-the-line culinary arts complex, a dining facility, and several multipurpose rooms that provide settings for a variety of conferences and seminars for business and industry. The Health and Culinary Center is also home to five High-Fidelity Nursing Simulation Labs. Also located on the Youngwood Campus is a stateof-the-art Science Innovation Center, a popular 425-seat theater that hosts both college and community events, and a Student Achievement Center that houses classrooms, academic offices, study areas, the Library, a 300-seat amphitheater, the College Store, a café, a gymnasium, an indoor running track, and a fitness center. Also located in the Student Achievement Center is the college's Event Center, which is used for college activities and also available for public use.

The college also has responded to the needs of its large service region by offering fullyoutfitted locations across southwestern Pennsylvania conveniently situated in the towns of Latrobe, Murrysville, New Kensington, Indiana, and Uniontown. Additionally, the college's Public Safety Training Center in South Huntingdon Township has emerged as a premier, in-demand training ground for the region's firefighters, police officers, emergency service personnel, and even federal law enforcement agencies. The college is also home to a 73,500-square-foot Advanced Technology Center (ATC), which offers credit programs, continuing education, and contract training for industrial technology manufacturing occupations. The ATC also houses the Westmoreland Makerspace District, a business accelerator for local, national, and global businesses and start-ups. Through the

ATC, the college has forged partnerships with world-renowned institutions, MIT. Carnegie Mellon University and Westmoreland's academic programs are exceptionally strong, and in 2023, the college received a glowing report as well as reaffirmation of its accreditation from the Middle States Commission on Higher Education. The College's Culinary Arts, Dental Assisting, Dental Hygiene, Medical Assisting, and Nursing programs all enjoy programmatic accreditation, as well. Since its founding, Westmoreland County Community College has continued to evolve to serve the community's needs, thanks in large part to a strong culture of philanthropy, partnership, and collaboration. #### Governance

The Board of Trustees of Westmoreland County Community College constitutes the governing body of the college, and is empowered to govern, operate and maintain the college under and in accordance with the Act and the policies, standards, rules and regulations which may be adopted, from time to time, by the Pennsylvania Department of Education.

The Board of Trustees is composed of 15 voting members who are appointed by the Board of Commissioners of Westmoreland County for terms of six years each. A Trustee may serve successive terms and each Trustee must continue to serve until a successor has been appointed and duly qualified. The President attends all meetings of the Trustees and may be heard on matters before it, but has no right to vote on any matter.

The Board of Trustees recognizes the value to governance of public comment and involving members of the public in Board meetings. In order to permit fair and orderly expression of public comment, the Board provides an opportunity at each regular and special meeting of the Board for the public to comment on official action or deliberation prior to the consideration of agenda items.



#### **Finances**

For FY23, of the approximately \$35 million-dollar budget, state appropriation funds total \$12.9 million, with tuition and fees comprising \$16.9 million. Westmoreland Community College has an integrated budget and finance system and has recently adopted Anthology Finance as its software.



#### The Foundation

Established in 1986, the Westmoreland County Community College Educational Foundation is dedicated to the mission, vision and values of our College and the community we serve, through community awareness, advocacy and financial support.

The Foundation is focused on securing philanthropic support to ensure that the vision of the President and Board of Trustees comes to fruition. Additionally, the Foundation reduces financial barriers to education for Westmoreland learners through scholarships and programmatic support.

During the 2023-2024 academic year, the Educational Foundation provided close to \$161,000 in scholarship support for students studying at Westmoreland.

In addition, the Educational Foundation has raised more than \$9.3 million in the past three years to help provide funding for the many new and innovative programs offered at Westmoreland.





### **Accreditations**

Westmoreland County Community College is accredited by the Middle States Commission on Higher Education (MSCHE). The Commission on Higher Education is an accrediting agency recognized by the U.S. Secretary of Education and the Council for Higher Education Accreditation.

Programs at the college are approved by the Pennsylvania State Department of Education for veteran's educational benefits. In addition, the following programs carry specific accreditation/approval by certifying/accrediting organizations:

- Culinary Arts, AAS and Baking and Pastry, AAS programs (Apprenticeship and Non-Apprenticeship) are accredited by the Accrediting Commission of the American Culinary Federation Education Foundation (ACFEF). These programs have been identified by the ACFEF as "Exemplary" and have received a Grant of Accreditation and Exemplary status through December 31, 2027.
- Dental Assisting and Dental Hygiene programs are accredited by the Commission on Dental Accreditation of the American Dental Association, a specialized accrediting agency recognized by the U.S. Secretary of Education and the Council for Higher Education Accreditation.
- Medical Assisting, Diploma, is accredited by the Commission on Accreditation of Allied Health Education Programs (CAAHEP) (www.caahep.org) upon the recommendation of the Medical Assisting Education Review Board (MAERB).
- Nursing, AAS program is approved by the Pennsylvania State Board of Nursing. The Nursing,
  AAS program is accredited by the Accreditation Commission for Education in Nursing (ACEN).

## **Roles and Expectations of the President**

Reporting to the Board of Trustees, the President serves as the Chief Executive Officer and is responsible for the overall operation of the college. The President articulates a common vision and guides the college in achieving its goals.



Serving as a visible advocate for the college's role in economic development, the President maintains and builds partnerships with business, industry, and local government and addresses the changes in the local economy by leading the college in developing programs and services to meet the needs of the community and the state.

The President also fosters strong ties with the college's funding sources, including state, federal, and local sponsors, and collaborates with other presidents to identify and achieve state-wide support for community colleges.

The President is responsible for overseeing strategic planning and institutional effectiveness plans and processing for the college and articulates and advances the student success and completion agenda for the college.

The President cultivates innovation throughout the college including, but not limited to, improving physical facilities through major capital projects, guiding the development of academic programs in emerging fields, and ensuring responsiveness to workforce needs.

In addition to being responsible for all employment-related decisions, the President supervises and evaluates the President's Cabinet.

The President attends all college Board of Trustees meetings and keeps the Board abreast of accomplishments and new developments at the college. The President also prepares reports and presentations for the Board of Trustees and submits and maintains an operating budget that adheres to college guidelines and reflects the long-range plans of the college.

The President ensures compliance with federal, regional, state, and program accreditation processes and performs other presidential duties assigned by the Board of Trustees.





## **Presidential Qualifications**

The college seeks an inspirational, collaborative, engaging, and approachable leader with a strong commitment to the philosophy and mission of a comprehensive community college. To be successful in this role, qualified candidates must possess the qualifications and experiences identified below:

- Commitment to shared governance and participatory management
- A history of successful senior-level administrative experience, preferably in a community college setting
- A demonstrated skill and knowledge of the following areas: academic policies and procedures, state and local government, executive leadership, and fiscal management
- The ability to identify new and alternate sources of funding and revenue generation
- Excellent communication, organization, and presentation skills
- Commitment to maintaining the college's existing culture of transparency.
- The ability to lead a strong executive team and to adapt to the changing landscape of higher education.
- A demonstrated ability to handle sensitive and difficult situations with tact and diplomacy while maintaining professionalism, confidentiality, composure, and a student-centered focus and attitude
- Demonstrated skills in and/or understanding of workforce development
- An earned terminal degree from a regionally accredited institution is required

In addition to the required qualifications listed above, experience with collective bargaining and fundraising is preferred.

## Westmoreland County, PA

Westmoreland County is situated in Pennsylvania's beautiful and rugged Laurel Highlands.
